On March 20, 2012, at approximately 1615 hours, Special Agent (SA) John Batchelor along with Investigator Jim Post of the Eighteenth Judicial Circuit conducted a recorded, sworn interview with at her residence.		
The following is a summary of this same interview and is not meant to be all-inclusive.		
said that she was home on the evening of the 26 <sup>th</sup> along with her sister, her niece and her niece's friend. The window in the kitchen which looks through to the rear of her home was half open and the back glass door was closed. While in the kitchen cooking she heard some kind of noise that she really could not make out. She said it sounded like kids but wasn't sure, because she had seen kids out there thirty (30) minutes earlier. She later describes the sound as a "groan" or "moan". She then looked out the window but really couldn't see anything. She moved over to the back glass door where she observed what looked like "figures". She could not make out if it was kids or not. It just looked like figures and arms moving. She could not describe any clothing or tell if they were black or white. She said that it was really dark back there. She describes seeing the neighbor whom she believes is and recalls him asking what's going on out there, and saying that he was going to call 911.  After said this, he closed his door and she went to turn off her stove. As she was in the process of turning off the stove she heard the gun shot. She then looked outside and saw what she describes as "the body" lying face down in a running position. She did not see anyone else. She describes the body or the person as being a black male wearing a reddish color jacket, grey sweat pants and black sneakers. She then went upstairs to tell her sister that she thought someone had been shot outside. She said that her niece and her
