



The undersigned attorney hereby requests the Clerk of the Court to furnish him with a copy of the information filed against the Defendant.



I, George Michael Zimmerman, was accepted into the Orange County Pretrial Diversion Program on 1-10-06, pursuant to Case Number 48-2005-mm-010436-D of the County Circuit Court of Orange County, Florida. As part of my Pretrial Diversion Contract Agreement, I agreed to remain under the supervision of the Pretrial Diversion Program for a period of Six (6) months. I am now advised by my Pretrial Diversion Officer that my program participation has not been satisfactory, and I hereby agreed to have my period of supervision extended for a period of two (2) months, with a new termination date of 9-10-06, in order to successfully complete the Pretrial Diversion Program.




To complete community service once proof of successful completion has been received and verified, PTD supervision may terminate early.

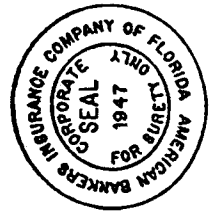
